Causes for Disqualification

Any team member who violates the following rules, not only disqualifies themselves, but also their entire team.

- No use of alcoholic beverages or drugs on railroad grounds. All alcoholic beverages and drugs are prohibited.
- No firearms on railroad grounds
- No foul, abusive or unacceptable language or any language causing a disturbance.
- No excessive noise, including, but not limited to that generated by speakers, such as radios, CD players, TVs, public address systems or amplifying equipment.
- No fighting or disorderly conduct.
- No theft, dishonesty, cheating or any act of moral turpitude.
- No use of any cooking device and heat source that is not officially recognized as part of the Iron Horse Cookery Cook-Off.
- Violation of any of the Iron Horse Cookery Cook-Off rules as stated above.

SAFETY RULES & REQUIREMENTS - The following cleanliness and safety rules must be adhered to:

- a. All participants must wear closed-toe shoes. This is a Safety Issue and there are no exceptions. Participants not wearing safe clothing and closed-toe shoes will not be allowed to participate.
 - b. The use of any tobacco products, including vape products, is prohibited except in designated smoking areas.
 - c. Cleanliness of the cook, assistant cook, runner, food preparer, food preparation area, cooking pots, and utensils in the team's food preparation area are mandatory.
 - d. Sanitizing of work area should be implemented with the use of a bleach/water rinse (one cup bleach per gallon of water.) Each team must provide a separate container for washing rinsing, and sanitizing of utensils.
 - e. Prior to cooking, all perishable food items must be maintained at 40 degrees or less.
 - f. **NOTE: Only participants wearing clothing made from all natural materials will be allowed in the cab of the locomotive.**
2. Due to health regulations teams are not allowed to provide food to anyone except Nevada Northern Railway Contest Representatives and Judges.

Registration Fee: \$200.00 (\$155.00 Team Registration Fee + 45.00 Refundable Cleaning Deposit)

Cleaning deposit will be returned upon final inspection and approval of the team's food preparation area by the NNRy Event officials following the event.
