

## **N.N. Ry. Steam Up Sweepstakes Official Rules**

2. Winners will be determined in random drawings to be held by the Nevada Northern Railway Foundation on July 25, 2025. Prizes will be awarded in order of stated value. All prizes will be awarded. The odds of winning one of the prizes are determined by the number of entries received.

4. There are three (3) methods of entry. Method #1 (online): To enter online, purchase a membership, renew a membership or make a contribution, visit [www.nnry.com](http://www.nnry.com) or click on the link in the online sweepstakes announcement and follow all online entry instructions to enter. Online entries must be received by 11:59 PM PDT on 7/21/25.

Method #2 (call in): You can enter by calling to the Nevada Northern Railway Museum (775) 289-2085 to purchase a membership, renew a membership or make a contribution.

Method #3 (personalized mail-in): To enter by mail with or without a donation, complete and return the Official Entry Form per instructions provided in the personalized offer you received in the mail (if you did not receive an Official Entry Form, you can request one by writing, NN Ry Sweepstakes, PO Box 150040, Ely NV 89315. Only one form will be sent per request. All must be received by 11:59 PM PDT on 7/21/25.

The number of entries you receive is dependent on the level of your membership, membership renewal or the amount of your contribution.

5. There is no obligation to make a contribution to enter. Limit 200 total entries per participant, regardless of method of entry.

6. Winners will be notified by telephone, email or mail. Any winner who cannot be located by certified mail sent to the address on entry form will, 30 days after notification, forfeit the prize; an alternate winner will be selected.

7. Employees of the Nevada Northern Railway Foundation as well as their spouses and dependents are not eligible to win.

8. Any taxes, licensing fees, registration, insurance or other consumer related charges on any prize are the sole responsibility of the prize winner.
